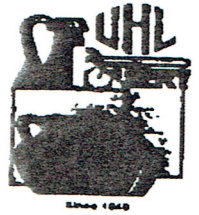




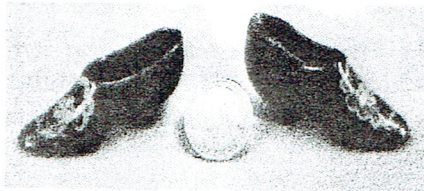

Uhl Convention Primer

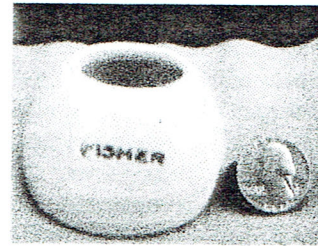
This will be our last publication of the Uhl newsletter. We found that we still had some items that we wished to share information about so this issue will be a primer for all the exciting Uhl pottery you will see at the convention.



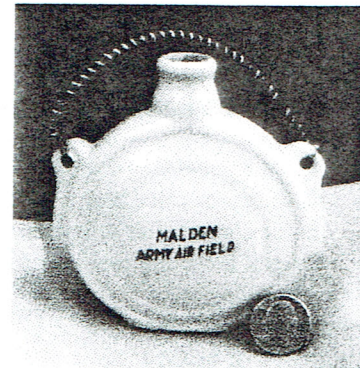
This miniature pair of ladies shoes with hand painted flowers is shown compared with a quarter for size estimation. These shoes have an unglazed bottom and can be marked with the word "uhl" in blue print. Some were hand painted like this example and some were even used as state fair advertising.



Here is a miniature "28" bellied jug with slanted top. This cute jug was found in a deep blue color with an unglazed ring on the underside and the number 28 in the center portion of the underside. (Note that the center portion on the underside of this jug is glazed.) It is shown with a quarter for size comparison.



This Fisher acid boat was made for Fisher Scientific Company by Uhl pottery. It is white with "FISHER" printed in blue on the front. The bottom is unglazed with no number or mark found on this particular piece. The acid boat is shown with a quarter for size comparison.



A canteen perfume jug with braided handle was designed to be a souvenir from Malden Army Air Field. The jug is white with an unglazed bottom and the word Botay on the underside. Botay Perfume Company was from Kansas City and ordered this unusual jug from Uhl. The words are in blue script and the opposite side has a pair of hand painted flags in the center area. It is shown compared to a quarter for size.

LETTER FROM THE PRESIDENT

June 1, 2000

Greetings to All,

As we begin a new season of hunting and discovering those elusive pieces for our collections, the UCS Convention 2000 is about to overtake us.

While a great deal of planning and preparation have gone into this very important event, there is always the gnawing feeling that something will be forgotten or of a major blunder occurring. We will keep our fingers crossed, knowing that glitches will occur that will require our attention and resolution.

First, apologies are in order for advising you of the wrong web site address for the UCS. We are certain that IT IS www.uhlcollectors.org, please make this correction.

By now you have received your 2000 commemorative, and isn't it a beauty? This of course is the case, if you properly and timely sent your reservation and payment for the piece by March 15.

The most difficult part of being an officer and especially president of the UCS, is have to say "No" to those who procrastinate and do not meet the order deadline. PLEASE, know that March 15, 2001 is the cut-off date for ordering the 2001 commemorative.

You will receive an order form with the January Newsletter. Please make it easy on us and the board, and especially yourself, by not delaying your order. If you do, at least write on your calendar a note two weeks prior to March 15.

If you do not receive a newsletter by the end of January, then call us or the newsletter/press secretary. Otherwise we must assume that you received the proper materials.

It is our hope that the labor strike at Jasper Cabinet will not affect our plans to have a display of seldom seen items at the convention. If everything goes as planned, the display will be in the Pecan Room on Friday after 2 p.m. and on Saturday a.m.

By now I suppose that you have been thinking of items to place in the auction on Friday evening. This year, the registration panel will grade any questionable items, using the four-point scale as follows:

- 1) Is it a known shape or size?
- 2) Is the glaze consistent with Uhl Production?
- 3) Is the clay similar to known Uhl production?
- 4) Does it have any mold number or marks consistent with Uhl pottery?

Any questionable items will be given a score of 1-4 according to these guidelines. As a result, we hope to help you in your purchase of auction items. A score of 3 is probably pretty good. A 4 even better!

There are three positions to be filled on the board. They are Secretary/Treasurer, Press Secretary (Newsletter editor), and a board member position. Please consider having your name placed in nomination. We want to emphasize that the UCS cannot operate unless there is a full array of positions filled. People in past positions have been extraordinary in helping new folks in becoming adjusted. Also, our meetings (4) are guaranteed to be lively and lift your spirits. We encourage you to call us (812-482-2492), about your interests in helping out. People are not flocking to assume these positions. Don't let us down on this request. If nothing else, call and ask questions.

Finally, we are looking forward to seeing you on June 23 and 24 at the Jasper Holiday Inn.

The miniature pitcher was found in a rose pink color. It has no mark or number on the unglazed bottom. The inside is in the Uhl white color. Please remember that any of the pieces can be marked although our example is not. A quarter is shown for size comparison.



These small loop handled pitchers were sometimes used as test glaze pieces. The bottom of this piece is about 98 per cent unglazed with numbers hand scratched into the unglazed portion of the bottom. It is possibly a test piece with the code number. The interior of this pitcher is a dark brown color. A quarter is shown for size comparison.



This miniature long necked pitcher was found in a yellow-green color inside and out. It has an unglazed bottom and no number or markings. A quarter is shown for comparison.

THE FOUR-POINT SCALE

- 1) Is it a known shape or size?
- 2) Is the glaze consistent with Uhl Production?
- 3) Is the clay similar to known Uhl production?
- 4) Does it have any mold number or marks consistent with Uhl pottery?

Any questionable items will be given a score of 1 to 4 according to these 4 questions above. For each positive answer then the piece receives 1 point. A score of 3 is probably pretty good and a 4 is even better!

Our board has continued to come up with more ideas to share information about Uhl pottery each year. This convention is going to have some interesting displays that have not been used before.

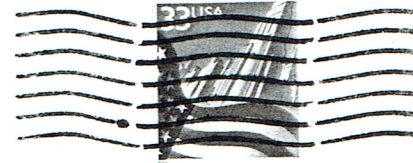
Remember that Uhl pottery collectors still have a long way to go when it comes to identifying all the pieces that were produced at the factories. However it gets a little closer to perfection with your help.
