COMMEMORATIVE PROCESS

Since the Uhl Collector's Society Club was founded, an annual commemorative was made for each member who chose to receive one.

All of us anxiously look forward to receiving it (to see the rumors were true) as to the choice for the year. In past years, the member picked up their commemorative at the annual convention in June. However several years ago, the board voted to mail the commemorative. Those paying prior to March 15th would receive one. This date is very important in helping us to determine how many commemoratives are to be manufactured. We normally add a small amount for breakage, hence the small number we have left over for sale at our Annual Meeting on Saturday morning of the Convention.

The selection of the annual piece usually begins the first Board meeting after convention. We continue to solicit suggestions from our Club members. The 2001 and 2002 commemoratives were suggested by members not on the Board and are in the process of being made.

All suggested ideas are discussed and considered and the selection is made with each Board member having a vote, a total of 7 votes with the majority ruling. Several things are taken in consideration in making our selection.

- (1) Size: can it be made as the original piece or can it be made as a miniature
- (2) Shipping Cost: size of package required, with weight also a consideration
- (3) Colors: can they be matched to the Uhl glaze
- (4) Surface: is the flat enough to accept the Uhl Collector's logo and the year
- (5) Clay: the color of the clay has

an effect on the glaze

- (6) Will it require a hand-turned piece or a molded piece
- (7) Do we have a pottery who is willing to produce it at a reasonable price After selections) is determined, an alternate piece is chosen. At this time my job begins in answering consideration # 7.

This task became one of my Board duties when I was elected in 1997, replacing Joann Smith, who chose not to serve again. At this time we had two Potteries to choose from. Since that time we have increased our possibilities to four. I've taken what we have chosen for the commemorative to each of the Potteries and described to them exactly what we want produced.

Each of the four has an advantage over the others. One is a specialist in hand-turned pieces. One specializes in jugs. One is much better in matching our (Uhl) colored glazes. One has an advantage as they have the original clay (Uhl clay) to use. For the present year, only one of the Potteries would agree to make this year at an affordable price.

The above specialties immediately eliminate one or more of the Potteries from serious consideration. The original piece of Uhl that we have chosen is taken to the Potteries and shown to them. When a pottery agrees to make the commemorative we leave the piece with them or they take photographs and measurements.

If it is to be a hand-turned piece, meaning every one will be an original, the Pottery is asked to supply a sample by the middle of December and a price.

If the piece is not hand-turned, the Potteries each have an expert to make a black

mold. The original mold is either plaster or rubber. The mold is hand carved exactly as the piece should look. The block mold, after being approved, is then used for the pattern in making as many plaster molds necessary to complete the order. For example, the 2000 commemorative required 40 molds for the top and 40 more for the saucer. At the conclusion of the project, I personally destroy all of the molds except one of each, in case, we would need more manufactured, and those are normally broken in November.

The sample is taken to the next Board meeting for approval or modification. The cost of the item is also approved.

The President of the Board will then take a sample piece to one of the prospective shippers to determine the cost of shipping and insurance. Also, some provision must be made for the packaging. All of the above must be determined prior to January Newsletter being mailed.

The Pottery chosen signs a contract with the Club for an approximate number of commemoratives (finally # determined by March 31st), the agreed upon price per unit and the date they are to be completed. All commemoratives are mailed on June 1st. My job from this time on is to continue to keep in contact with the Pottery, checking on the quality and quantity and delivering the finished products to Dubois Country for packing.

The Board hopes that you will be pleased with what we have chosen and that the commemorative will continue to increase in value, as we are just beginning our collection or continuing to build our existing Uhl collection.

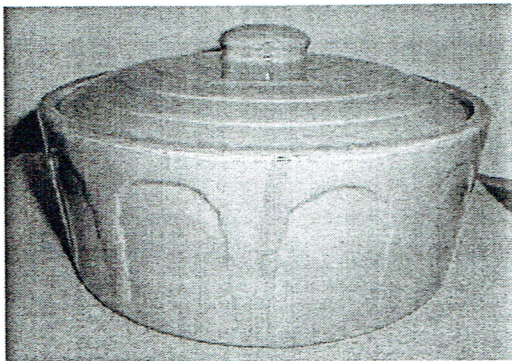
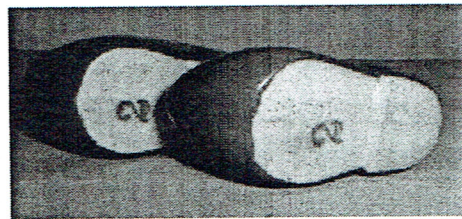
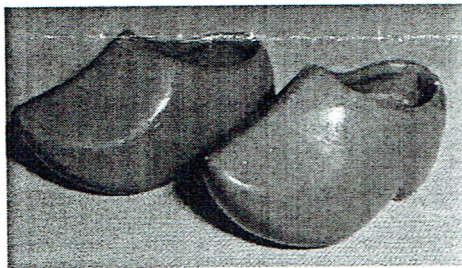
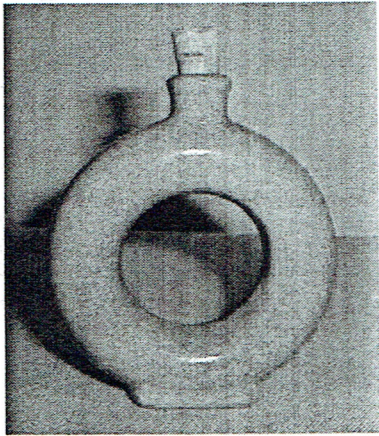
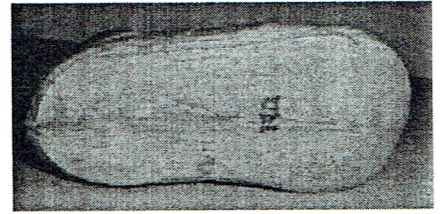
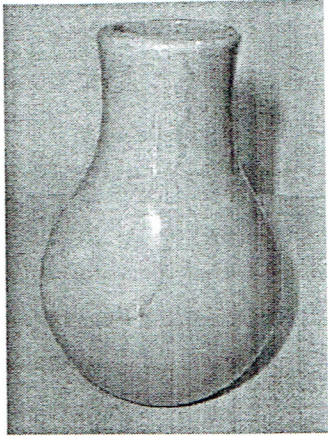
NEEDING SOME POTTERY REPAIRED??

Doing my usual daily search through eBay, I found some great pieces of pottery bringing some hefty prices. What was interesting to me is that they had been professionally repaired. Viewing their pictures, a person would not be able to spot the repair unless the honest seller would have told you. Come to find out, the seller was the repairer. With his permission, I am passing on the following email sent to me:

We are always looking for new customers so we would welcome items. We do guarantee all our work and as of this date we have had no complaints. Our policy is as follows: 1) Item is to be sent by Registered Mail, Return Receipt Request 2) We first estimate the repair cost, then notify you for approval prior to repairing 3) At completion, the owner will be contacted to send a check including shipping and insurance cost. 4) Item will be returned by Registered Mail ONLY, to insure safest shipping practice We again thank you for your interest in our service. COMMEMORATIVE SHIPPING

In the past we have attempted to mail the commemoratives on or about June 1. This year there will be a delay and we plan shipment by USPS Priority Mail on June 12. Most of you should receive your piece by June 15. This year, the piece is being made by a potter in Kansas City and will be hand turned. We believe that the frustration of your short wait will be satisfied by the uniqueness of the piece.

FRIDAY AUCTION

The board of directors has approved the following regulations that will be followed for the auction on Friday evening. 1. Only pre-1943 Uhl Pottery pieces and authentic Uhl Collectors Society annual commemoratives will be allowed. Those pieces made in the late 1980's to the present time for the purpose of advertisement will not be allowed. 2. Uhl Pottery related ephemera will be allowed. 3. Mixed box lots will not be accepted unless the box contains similar items and/or are considered a part of a set. A mixture of small items such as a small jug, a lid, a piece without a lid, and a vase would not be accepted. The suitability of box lots will be determined by those working at the registration table and any elected officers who might be present at the time. 4. The four point scale will be utilized to determine authenticity of individual auction items. The scale is as follows: a. Is it a known shape or size? b. Is the glaze consistent with Uhl production? c. Is the clay similar to known Uhl production? d. Does it have any mold number or marks consistent with Uhl Pottery? Each piece will receive a score of 1 through 4, according to the above questions. For each positive answer, a piece will receive one point. If a piece receives a score of "3", it is likely a good piece. A score of "4" would be even better. Pieces receiving a score of less than "4" will be announced before its sale.

SATURDAY MORNING PUBLIC SALE

There has been some discussion and suggestions that the Saturday public sale be reduced from 2 hours to 1 1/2 hours. Currently, the sale runs from 8-10 a.m., with the annual membership meeting beginning at 10:00. The board has decided to look into this situation further and that it deserves further study. Therefore, this year the sale will again run from 8:00-10:00 with the possibility of change next year. Those who regularly set up their wares should express their opinion (pro's and con's) to someone who will be an officer next year.

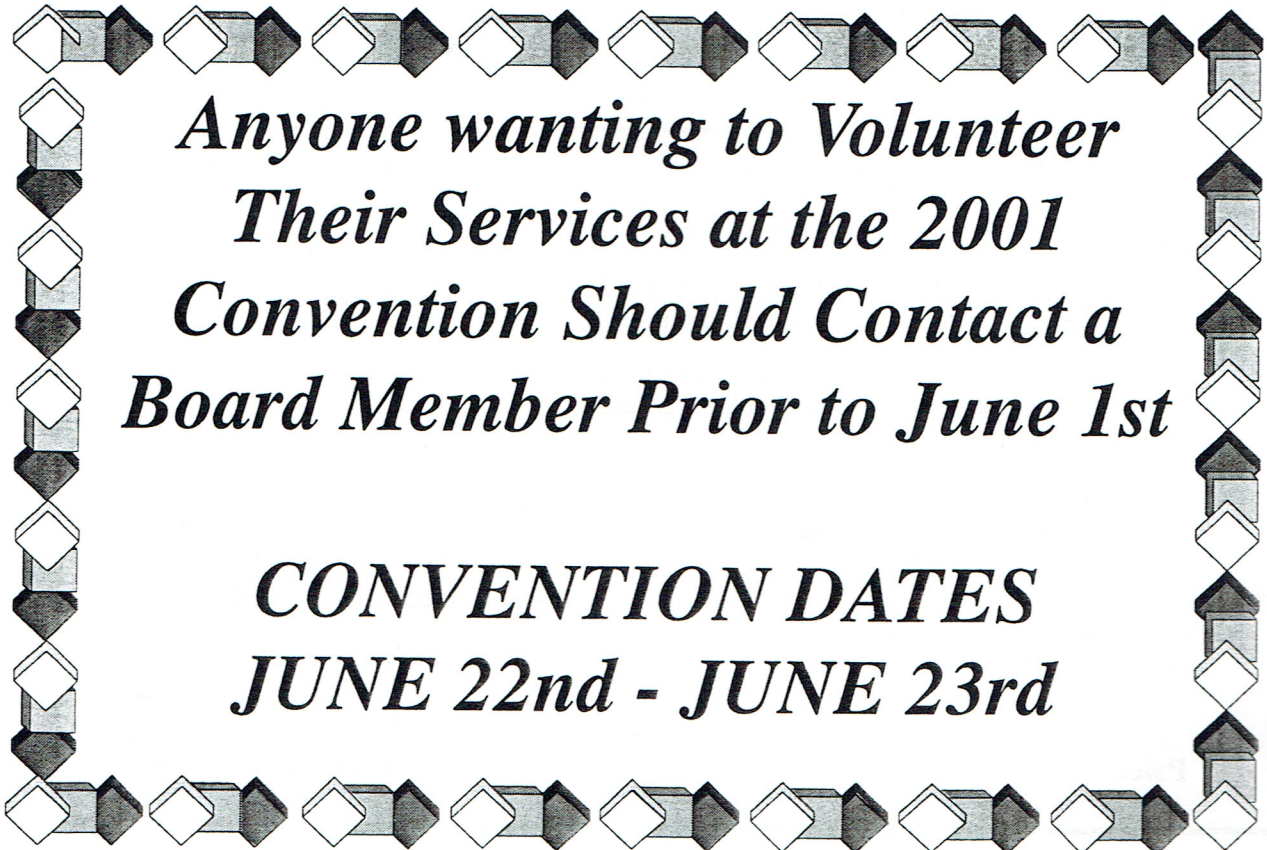
