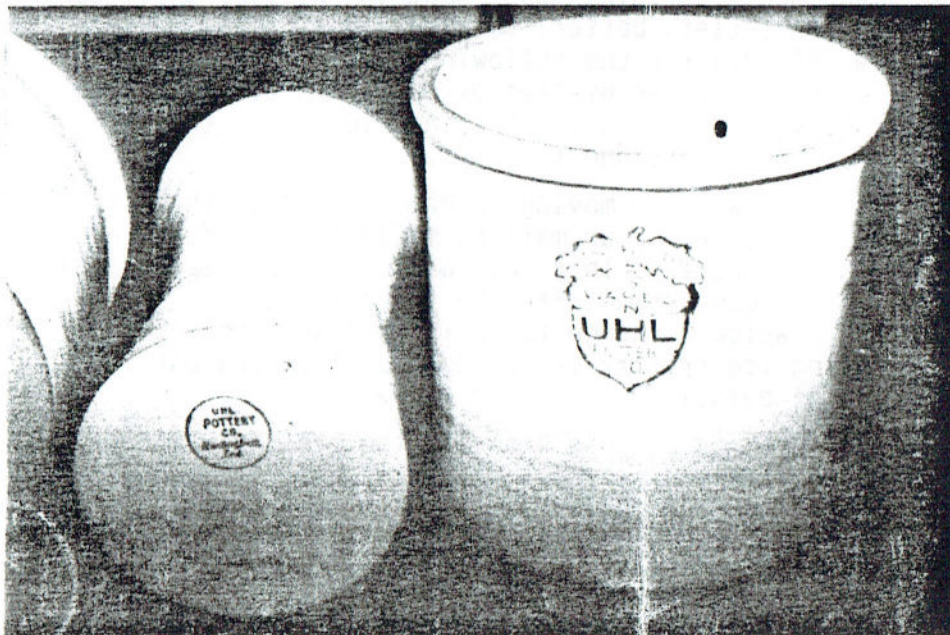

Below is a photo of the reproductions in an open jar and a vase. The vase has the date of Sept. 1988 on the base at the bottom of the picture.



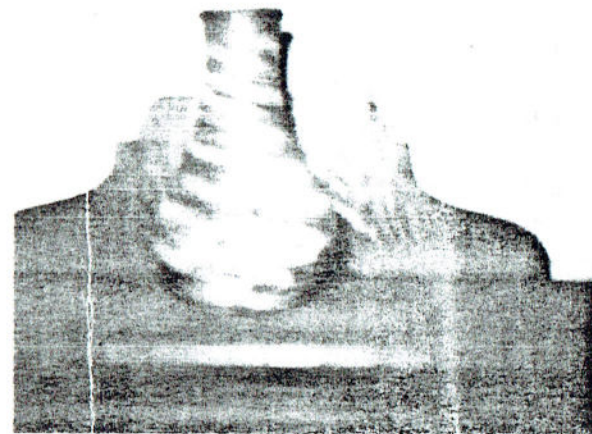

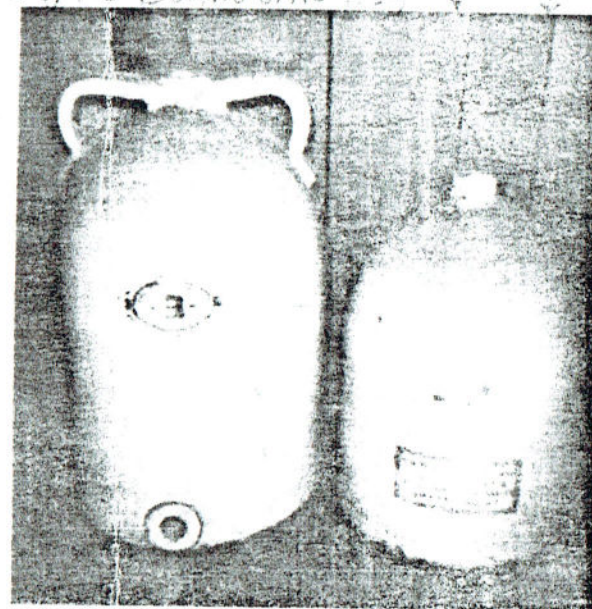
